3. Purpose of processing personal data:

Personal data will be processed and saved to accomplish the requirements of the membership relation, e.g. invitations to general assemblies, financial transactions.

4. Legal basis:

The processing of personal data takes place due to the necessity to fulfil a contractual relationship according to Art. 6(1)(b) GDPR. The contractual relationship is the membership in the association.

5. Recipients or categories of recipients to whom the personal data have been or will be disclosed:

For the purpose of financial transactions details on personal bank account data is disclosed to "VR-Bank Altenburger Land eG".

6. The period for which the personal data will be stored, or if that is not possible, the criteria used to determine that period:

Personal data will be stored for the duration of the membership. The personal data will be erased on withdrawal from the membership. Personal data regarding cash management, which have to be stored in a locked state for up to 10 years due to tax law regulations.
